A regular meeting of the Iva Town Council was held on Monday, April 8, 2019 at 10:00 a.m. in the Council Chambers of the Iva Town Hall, located at 204 E. Jackson Street in Iva. Notice of the meeting was given in compliance with the South Carolina Freedom of Information Act.

1. **Call to Order – The meeting was called to order by Mayor Gentry**
2. **Invocation and Pledge of Allegiance – Ms. Forrester offered the Invocation. Following the Invocation, everyone stood and pledged allegiance to the flag of the United States of America.**
 - Ms. Ruby Cain provided an update to the Mayor and Council regarding the Iva Antique Body Shop. Ms. Cain commented that the gym has been doing great over the last three months.

- There is currently four officer on regular patrol, five as SRO's and one employee in the Water Department.
